Recommencement of Oneday Service with effect from 25.10.2021 for issuing National Identity Cards which was temporarily suspended.

The Department for Registration of Persons has decided to recommence **Oneday service of issuing National Identity Cards with effect from 25.10.2021** for the applicants who get assigned date and time for obtaining National Identity Cards which was temporarily suspended due to covid 19 pandemic situation.

02. Arrangements have been made to issue National Identity Cards under one day service at the Head office situated in Battaramulla and at Southern provincial office for limited number of applicants taking into consideration the risky situation of aggregating a large number of persons at the Departmental Premises at once.

03. Accordingly, the applicants who wish to obtain National Identity Cards through Oneday service shall get their application certified by the Grama Niladhari and visit the Identity Card Branch at the relevant Divisional Secretariat. A convenient time and a date to visit shall be get assigned from there and the applicant shall visit the Department on time on the prescribed date. If he/she fails to visit on the due time on the due date, he/she shall visit the Divisional Secretariat again and shall make an appointment for another date.

04. At present, the applicants who have already got assigned token to obtain National Identity Cards under Normal service have also been provided with facilities to visit the Department on the due date and to obtain their Identity Cards. Additionally, those who wish to apply National Identity Cards under normal service may send their applications to the Department through the Grama Niladhari and necessary arrangements have also been made to issue expeditiously such National Identity Cards within a very short period.

05. Furthermore, all the applicants who visit the Departmental Premises shall strictly and properly adhere to the health guidelines.
